


Enrolment Ratio increased up to 85.6% in 2016 and it is targeted to be 100% in 2024.

Education training in Uganda is governed by the Education Act (2008) and other acts of parliament including Universities and other Tertiary institutions Act and Charters of Universities(2001).

The Ministry of Education and Sports is responsible for providing for, supporting, guiding, coordinating, regulating and promoting quality education and sports to all persons in Uganda for national integration, individual and national development. Since 2000, there has been enormous progress in achieving the target of universal primary education. The total enrolment rate in developing regions reached 91 percent in 2015

THE UGANDA GOVERNMENT STRATEGIES ON ENSURING QUALITY EDUCATION

The decision to re-cost and update the strategic plan was prompted by the addition of six items to Uganda's education policy agenda since the launch of the ESSP 2004-2015:

Bringing the ESSP into full conformance with EFA FTI goals (the ESSP2004-2015had been designed to fit within financial constraints).

Improving the quality of primary education through introduction of local language instruction and a simplified thematic curriculum.

Ensuring that all pupils successfully completing Primary 7 have access to either academic secondary education or BTVET.

Strengthening science and technology education by providing science laboratories, ICT laboratory rooms, and well-stocked libraries to secondary schools.

Increasing participation in tertiary education in order to ensure that Uganda meets its needs for high-level work force.

Increasing the attractiveness of the teaching profession through the introduction of a scheme of service that creates a career ladder for teachers and school administrators and differentiates salaries in recognition of career status, (Ministry of education and sports draft report, 2015).
