Terms and Conditions

- 1. Coaching fees are strictly payable in advance, on or before the 7th of every month.
- 2. If fees are paid later than the agreed period, an automated late penalty of R150 will apply on the parents account in the next month. The services will be suspended till fees are paid up.
- 3. In the event that you wish to terminate the contract. You must give one month's written notice. You will be billed for this months' notice irrespective whether the session is attended or not. Should you not give your notice in writing; you will be liable for the month's fees. NO verbal notices to coaches will be accepted.
- 4. All termination letters should reach the office by the 1st of October, October shall then be the last month of training. No termination shall happen in November or December.
- 5. Should you terminate the contract for one or two months and return, a re-registration fee will be applicable.
- 6. Should the parent withdraw from TuksTennis without one month's notice and the outstanding fees are not being paid off, a letter of demand will be issued. The parent will be liable for all attorney's fees on the cliental and attorneys scale, and all additional charges incurred on collection of fees owed.
- 7. This is a yearly agreement, TuksTennis invoices for 10 months or 11 months. All payments should be paid by 7 October or 7 November depending on which option you choose.
- 8. If a player cannot attend training for any reason (holiday, school tour, injury etc), the player is welcome to make up lessons whenever possible upon their return. If the player is injured and cannot attend training for 2 months or more, a written notification from the doctor should be served within 7 days. The finance department will discount the account by a certain percentage.
- 9. The parent acknowledges and agrees that neither TuksTennis nor any of its employees, contractors or agents shall be liable for any injury, loss or damage sustained by the player.
- 10. The parent gives TuksTennis permission to place photos of your child on our facebook or the website unless otherwise.
