- 17.17.8 If shower screens are installed, the width of the entrance to the roll-in shower must be at least 800mm wide and there must be sufficient turning space of 1100mm X 1200mm inside the cubicle
- 17.17.9 A fixed shower head must be installed at a height of 2100mm (2,1m) above the floor finish and/or a shower head on a vertical bar with the top of the bar at a height of 2100mm (2,1m) from the floor finish. The shower hose length must be 1500mm (1.5m).
- 17.17.10 The shower taps must be mounted on the same wall as the cranked bar, easy to use and accessible from the shower seat

# 17.18 Bathrooms: Accessories

17.18.1 Bin with an easy to use lid must be provided

#### 17.19 Public Spaces: Lifts

- 17.19.1 Lifts must be located en-route to accessible units where such facilities are not located on the ground floor
- 17.19.2 Size of unobstructed approach space to the lift must not be less than 1200mm X 1500mm
- 17.19.3 Clear opening width of the entrance door must not be less than 800mm
- 17.19.4 All controls, internal & external, must be between 900mm 1200mm from the floor finish. Emergency controls must be no higher than 900mm
- 17.19.5 Emergency telephones should have amplified volumes and ringers
- 17.19.6 150 lux minimum internal lighting level
- 17.19.7 The internal size of the lift car must be no less than 1100mm x 1400mm
- 17.19.8 A horizontal handrail must be fitted to the full length of at least two sides of the lift car at a height of between 850mm to 1000mm from the floor finish
- 17.19.9 The back wall of the lift car above the handrail must be fitted with a mirror

# 17.20 Housekeeping Services: All areas

17.20.1 Housekeeping staff to ensure all unit accessories and equipment are within easy reach of guests. Care to be taken to ensure everything remains in the same place

# 17.21 General Services & Service: Welcome, Friendliness and Attitude

- 17.21.1 UA Sensitivity Training for managers and staff who interface with guests
- 17.21.2 On arrival guests are provided with an orientation on their navigation around the facilities and information on emergency procedures
- 17.21.3 Website or other marketing collateral provides sufficient pre-booking information on all UA services and facilities
- 17.21.4 Assistance with information about accessible tourism products and bookings provided by staff.
- 17.21.5 Staff to be available to assist with check-out procedures

# 18.1 Building Exterior & Interior: All areas

- 18.1.1 Well lit, clear and legible signage on a contrasting background with a minimum font size of 120mm
- 18.1.2 Further use of integrated decor features to indicate change of areas and surfaces so as to facilitate navigation around the property
- 18.1.3 All ramps must have a minimum 1:12 gradient and a width of no less than 1100mm (1.1m) and maximum camber 1:50. All ramps must have a landing at the top and bottom with additional landing every 10000mm (10m). The landing must not be less than 1200mm (1,2M) in length and clear of any door swing.
- 18.1.4 Ramps must have handrails on one side at a height of between 900 and 1000mm and a maximum camber of 1:50 and tapping rails on the open side of at least 100mm. Handrails must extend 300mm before and beyond the end of the ramp
- 18.1.5 All staircases must have handrails on one side at a height of between 900mm and 1000mm or a stair lift must be provided. Handrails must extend 300mm before and beyond the end of the staircase.
- 18.1.6 Handles must measure at least 120mm in length and be easy to grasp. D-Type handle must be used
- 18.1.7 A Minimum space of 900mm 1000mm between the furniture and fittings to allow for ease of access. Any room configuration must allow for an unobstructed turning space of at least 1200mm in at least one area
- 18.1.8 There should be a lighting transition zone inside the entrance door

#### 18.2 Building Exterior: Parking, Driveways, signage

- 18.2.1 Distance from designated parking bays to entrance maximum of between 10m and 20m
- 18.2.2 Gradient en-route to entrance from street or designated parking bay, not steeper than 1:15
- 18.2.3 A covered parking bay
- 18.2.4 Signage for guests with visual limitations must be displayed in a larger font and in Braille

#### 18.3 Safety & Security: General

- 18.3.1 Emergency information & Procedures clearly displayed in English and/or pictograms at a height of between 1400mm and 1700mm above finished floor level
- 18.3.2 Unit door must have easy to use electronic locking system
- 18.3.3 Multifloored units to have a fire extinguisher on each floor

# 18.4 Bedrooms: Wardrobes, Shelves and Luggage Storage

18.4.1 D-type handles to be provided

#### 18.5 Bedrooms: Form of Bedding (Beds, Bases and Mattresses)

18.5.1 Unobstructed turning space of more than 1200mm on at least one side of the bed without rearranging the furniture

#### 18.6 Bedrooms: Lighting/Power/Switches

- 18.6.1 Power sockets located between 800mm and 1000mm above floor level. Close to headboard and at desk
- 18.6.2 All main light controls accessible from the bed
- 18.7 Bedrooms: Mirror and Mirror Lighting
- 18.7.1 An available portable magnifying vanity mirror

#### 18.8 Lounge Dining, Patio: Lounge

- 18.8.1 Sub-titles to be provided on television services where available
- 18.8.2 Where televisions are provided, listening devices are provided
- 18.8.3 Where televisions are provided, induction loops are provided

## 18.9 Kitchen: Provision

18.9.1 Refrigerators or freezers should be configured with at least 50% of the freezer space a maximum 1200mm (1.2M) above the floor and incorporate clear floor space in front

#### 18.10 Bathrooms. Toilet & Public Toilets: Fixtures and Fittings

- 18.10.1 Hot water temperature must be set at 55 degrees maximum
- 18.10.2 Basin to be adjacent to the toilet and located no more than 300mm from the toilet seat to enable user to wash hands while seated. All towel rails positioned adjacent the basin at a height of 900mm to 1000mm.
- 18.10.3 All taps must be lever action mixers

# 18.11 **Public Spaces: Lifts**

- 18.11.1 The internal size of the lift car must be 1200mm x 1600mm or more
- 18.11.2 Clear opening width of the entrance door to be more than 800mm
- 18.11.3 Flashing lights should be linked to alarms and emergency buttons

# 18.12 Additional Facilities: Swimming Pool

- 18.12.1 Safe access into the swimming pool
- 18.12.2 An accessible changing room and toilet must be provided, in close proximity to the swimming pool

# 19.1 Building Exterior & Interior: All areas

- 19.1.1 All ramps must have a minimum 1:15 gradient and a width of no less than 1100mm (1.1M) and maximum camber of 1:50. All ramps must have a landing at the top and bottom with additional landings every 10000mm (10M). The landings must not be less than 1200mm (1.2m) in length and clear of any door swing
- 19.1.2 All ramps must have handrails on both sides at a height of between 099mm and 1000mm and tapping rails on the open side of at least 100mm. Handrails must extend 300mm before and beyond the end of the ramp.
- 19.1.3 All Staircases must have handrails on both sides at a height of between 900mm and 1000mm or a stairlift must be provided. Handrails must extend 300mm before and beyond the end of the staircase.
- 19.1.4 All Staircases must have tapping rails on both sides at a height of 100mm.
- 19.1.5 A space of more than 1000mm between the furniture and fittings to allow for ease of access.
- 19.1.6 Furniture should have rounded edges to prevent injury to guests

# 19.2 Building Exterior: Parking, Driveways, signage

- 19.2.1 Distance from designated parking bays to entrance of less than 10m
- 19.2.2 Garage parking with direct access to the building.
- 19.2.3 Signage and relevant information for guests with visual limitations must be displayed in a larger font and in Braille
- 19.2.4 Emergency information and procedures clearly displayed in English and/or pictograms at a height of between 1400mm and 1700mm above finished floor level

#### 19.3 Bedrooms: Curtains and Window Coverings

19.3.1 Curtains and window coverings fitted with electronic closer mechanism

#### 19.4 Bedrooms: Form of Bedding (Beds, Bases and Mattresses)

19.4.1 Unobstructed turning space of at least 1200mm width on both sides of the bed without rearranging the furniture

#### 19.5 Bedrooms: Lighting/Power/Switches

19.5.1 All main light controls accessible from the bed or sound and motion sensors must be provided

## 19.6 Lounge Dining, Patio: Lounge

19.6.1 Where televisions are provided, induction loops are provided

#### 19.7 Bathrooms: Provision

19.7.1 UA bathrooms to be more than 1800mm X 1800mm

#### 19.8 Bathrooms, Toilets & Public Toilets: Provision

19.8.1 There must be a minimum of two bathrooms, one with transfer from the left and the other with transfer from the right.

#### 19.9 Bathrooms, Toilets & Public Toilets: Accessories

19.9.1 Bin with a motion sensor lid is provided

#### 19.10 Public Spaces: Lifts

- 19.10.1 Automatic door enunciator
- 19.10.2 Emergency telephones or intercom to have braille and tactile buttons
- 19.10.3 A horizontal handrail must be fitted to the full length of at least two sides of the lift car at a height of between 850mm x 1000mm from the floor finish
