

### General admission regulations that apply to all prospective students

- 1. The admission requirements and general information provided in this Faculty brochure are applicable to students who apply for admission to the University of Pretoria with a National Senior Certificate (NSC) or an Independent Examination Board (IEB) qualification.
- . The following persons will be considered for admission to a first bachelor's degree at the University of Pretoria:
  - Candidates who have a certificate that is deemed by the University to be equivalent to the required National Senior Certificate (NSC) with bachelor's degree endorsement;
  - Candidates who are graduates from another tertiary institution or have been granted the status of a graduate of such an institution; and
  - Candidates who are graduates of another faculty at the University of Pretoria.
- 3. Grade 11 results are used for the conditional admission of prospective students, but final admission will depend on the NSC (or equivalent) qualification and results.
- 4. Candidates must also comply with the specific subject and achievement level requirements and the minimum Admission Point Score (APS) for their chosen degree programmes.
- 5. The APS calculation is done by using the NSC 1 to 7 scale of achievement. It is based on a candidate's achievement in six recognised 20-credit subjects. The highest APS that can be achieved is 42. Life Orientation is a 10-credit subject and is excluded from the calculation when determining the APS. The following subject rating scores are used for calculating the APS for NSC/IEB:

- 6. Except in cases where modules or programmes require the use of a language other than English, all modules will be presented in English, which is the University's official language of tuition, communication and correspondence.
- 7. Minimum requirements for admission to the relevant programmes are set out in the minimum admission requirements table in this brochure.
- 8. Meeting the minimum admission requirements does not guarantee admission into a programme.
- Applicants with qualifications other than NSC and IEB should refer to the following publications:

- 10. **School of Tomorrow** (SOT) and **Accelerated Christian Education** (ACE): The University of Pretoria no longer accepts qualifications awarded by these institutions.
- 11. General Education Development (GED): South African GED graduates who graduated up to 2019 may be considered for admission, provided they qualify for an exemption certificate issued by USAf and comply with both University admission and Faculty subject requirements. South African GED graduates who graduated after 2019 cannot be considered for admission to UP as the diploma is not accredited by USAf and will not be considered for exemption. Applicants from the USA who completed the GED may apply for a Foreign Conditional Exemption Certificate issued by USAf and accompanied by their SAT/TOEFL/IELTS results.
- 12. National Certificate (Vocational) (NCV) Level 4: The University of Pretoria may consider NCV candidates, provided they meet the exemption for bachelor's status criteria and the programme requirements.

### APPLICATION AND CLOSING DATES:

- Applications open on 1 April. All study programmes at the University of Pretoria are number-limited. You are encouraged to submit your
  application as soon as possible after 1 April.
- The closing date for applications for all UP study programmes is 30 June. This excludes the programmes in the Faculty of Veterinary Science which close on 31 May.

### APPLICATION STATUS:

- Apply with your final Grade 11 (or equivalent) results.
- Please note that meeting the minimum academic requirements does not guarantee admission.
- Successful candidates will be notified once conditionally admitted.
- Unsuccessful candidates will be notified after 30 June.
- Please check your application status regularly on the UP Student Portal at www1.up.ac.za.
- Final admission will be based on the applicant's final school-year NSC or equivalent results.



### Faculty-specific admission regulations

- The following persons will be considered for admission: Candidates who have a certificate that is deemed by the University to be equivalent to the National Senior Certificate (NSC) with admission to bachelor's degree studies; candidates who are graduates from other tertiary institutions or have been granted the status of graduates of such institutions; and candidates who are graduates of another faculty at the University of Pretoria.
- Life Orientation is excluded when calculating the APS.
- All modules will only be presented in English, as English is the language of tuition, communication and correspondence.

Note: Accounting at school is not a subject requirement for any of the BCom and BAdmin programmes.

To register for a first bachelor's degree at the University of Pretoria, an applicant should have completed the National Senior Certificate or equivalent qualification and meet the minimum requirements for the relevant programme.

The calculation of an Admission Point Score (APS) is based on a candidate's achievement in any SIX recognised NSC 20-credit subjects. Achievement is measured by using the NSC seven-point rating scale. Life Orientation is a 10-credit subject and is excluded from the APS calculation. Life Orientation is also not a Faculty-specific subject requirement.

### An exciting student life awaits

Commercii, the student house of the Faculty of Economic and Management Sciences, is a society that caters to the needs of BCom and BAdmin students registered in the Faculty and helps first-year students to 'find their feet'. Commercii works in close collaboration with the various discipline-specific sub-houses to curate valuable experiences for students to learn skills that will empower them to be leaders, both on campus and later in the workplace.

During your time as an EMS student, there will be numerous opportunities for you to enhance your leadership and academic development skills, participate in community outreach projects and have social interactions that make student life worthwhile.

### **BCom (Accounting Sciences)**

### What does the programme entail?

The BCom (Accounting Sciences) degree is a three-year programme that is followed by the one-year Postgraduate Diploma in Accounting Sciences (PGDAS), which is required in order for graduates to comply with the education requirements for the Chartered Accountant qualification, CA(SA). Successful completion of these two study programmes will provide access to the Initial Test of Competence (ITC), which is the first of two professional exams set by the South African Institute of Chartered Accounting (SAICA).

Thereafter, a three-year traineeship needs to be completed, during which time the applicable professional qualifying examinations must be passed to qualify a candidate to register as a CA(SA).

### What makes this programme unique?

The BCom (Accounting Sciences) degree and the Postgraduate Diploma in Accounting Sciences are accredited by SAICA and form part of the requirements for training as a CA(SA), which is the highest professional designation in accounting in South Africa and enjoys international recognition.

The undergraduate degree is also accredited by the Association of Chartered Certified Accountants (ACCA).

Over and above the prestigious CA(SA) qualification, the three-year BCom (Accounting Sciences) degree also provides access to the following BCom Honours degrees (subject to selection):

- BComHons (Financial Management)
- BComHons (Internal Auditing)
- BComHons (Taxation)

### **Career opportunities**

Qualified CAs(SA) are able to fulfil business and finance roles in a variety of industries. They tend to specialise in auditing and assurance, tax, financial management, information technology, management accounting, forensic accounting and insolvency.



Employment opportunities also exist in academia, the public or private sector and non-governmental organisations, to name but a few.


Those who have a CA(SA) qualification also succeed in CEO, CFO, vice-president, chairperson and finance manager roles, or can become entrepreneurs.

### **BCom (Business Management)**

### What does the programme entail?

The BCom (Business Management) degree is for students who would like to become business leaders and be employed in an organisation, or even create their own employment. This programme provides a big-picture view of the organisation as a body with separate but interdependent parts and students are taught how all the parts function as a whole.

**Careers:** Although the degree does not lead to a specific vocational outcome it does, to some extent, offer students opportunities to determine their own career paths as it allows them to compile their own curricula with a view to future work opportunities in all sectors.





### **BCom – Extended Programme**

### What does the programme entail?

The BCom – Extended Programme has lower entrance requirements than other BCom programmes. It provides students with the opportunity to pursue a career in commerce by following an extended curriculum.

#### The Extended Programme comprises two distinct phases:

#### Phase 1: First year (Mamelodi Campus)

- Content is delivered at a reduced pace using a variety of methods to remedy possible gaps in foundational knowledge.
- Smaller tutorial groups allow for more individual attention and dedicated support to students.
- Students are assisted to develop critical thinking and practical skills, which are crucial to long-term academic success.
- Focused attention is placed on developing students' language skills since good reading and communication skills are essential in the study and work environment.

#### Phase 2: Second to fourth years (Hatfield Campus)

- Students must pass all their modules during Phase 1 to be transferred to Phase 2.
- Degrees in the Management Sciences are immediately accessible at the commencement of Phase 2.
- Transferral to degrees with a National Senior Certificate Mathematics requirement of 5 and above is only possible if students meet the stringent transfer requirements set out in the EMS Transfer Guide (see www.up.ac.za/ems) by the end of their first year on the Hatfield Campus.

### **Career opportunities**



Career opportunities are dependent on the BCom degree that a student continues with once they have completed their first year at the UP Mamelodi Campus.

### What makes this programme unique?



The BCom – Extended Programme is designed to accommodate students who did not initially meet the minimum admission requirements for

the BCom degree they wish to pursue. Such students need more academic support and a stronger foundational basis, but if they are willing to work hard they will achieve success, earn their degree and realise their goals.

### Minimum admission requirements

### Who are the ideal candidates?

This programme caters for students whose National Senior Certificate (NSC) results do not comply with the minimum admission requirements for their degree of first choice, or those who are uncertain about what to study when enrolling at UP.



### Structure of the programme

The first year of study is offered at the Mamelodi Campus. This is the ideal starting point for students who are interested in studying towards a BCom degree in management and financial sciences. During October of their first year of study, students have to apply to be transferred to the Faculty of Economic and Management Sciences on the Hatfield Campus. All first-year modules must be passed before a student can be transferred to any of the BCom programmes.

The BAdmin (Public Management and International Relations) programme is directed towards the study of Public Administration to equip students for a career in the public sector.

The degree provides in-depth knowledge of certain administrative and management practices in the South African and international public sectors. It focuses on the three spheres of government, namely the local, provincial and national levels.

Some of the key aspects studied are public financial and human resources management, international administration and management, policy and organisation studies, ethics, project management, intergovernmental relations and administrative justice.


