
# Tshwane Substance Use Research Symposium FACILITATORS & SPEAKERS



## **Prof Jannie Hugo**

Jannie Hugo is the Director of the Community Oriented Primary Care (COPC) Research Unit at the University of Pretoria. He is leading the academic development and implementation of COPC, including mobile data systems and the implementation of the Community Oriented Substance Use Programme (COSUP) in collaboration with the City of Tshwane and the Gauteng Department of Health.

#### Mr Koena Nkoko

Mr Koena Nkoko is a seasoned and experienced executive leader. He has over 20 years of experience in the Health Sector, mainly in district health services and local government. 
#### Mr MJ Stowe

MJ Stowe is a Researcher at the Community Oriented Primary Care (COPC) Research Unit at the University of Pretoria in the Community Oriented Substance Use Program (COSUP), and Programme Coordinator at the South African Network of People Who Use Drugs (SANPUD). MJ's research interests include i) drug-related harms among people who use drugs (PWUD); ii) drug checking in festival and community settings; iii) racial inclusivity in harm reduction and drug policy reform in South Africa; and iv) increasing community-based access to naloxone and opioid overdose education through take-home naloxone programmes. MJ's work revolves around community engagement and ensuring that PWUD are meaningfully involved in service delivery, advocacy and drug policy reform activities and efforts in South Africa.



## Mr Kamogelo Letswalo

Kamogelo Letswalo is a peer educator at the Community Oriented Substance Use Programme (COSUP) in Atteridgeville. He is an advocate for harm reduction and for the substance users involved in this programme. He has been involved in COSUP for the past four years. Initially, he was invited to give motivational talks for COSUP support groups and then volunteered for eight months, after which he became an official peer educator.





#### Mr Shaun Shelly

Shaun Shelly is the Drug Policy lead at TB HIV Care, a researcher at the University of Pretoria, Department of Family Medicine, and Chair of the South African Network of People Who Use Drugs (SANPUD). He is a former Deputy Secretary of the United Nations Vienna NGO Committee (VNGOC) on Narcotic Drugs and sits on several boards and expert groups internationally. Shaun has written more than 25 peer-reviewed journal articles, chapters and reports. He brings academic, programmatic, research, clinical and lived experience together into a 360 degree-view of the complex issues that inform our understanding and responses to the use of certain drugs, and the people that use them.



## Mrs Hanlie Kapp



Mrs Hanlie Kapp has managed several PEPFAR funded programs within the Foundation for Professional Development (FPD) since joining the company in July 2009. During her tenure she managed and implemented the award-winning First Things First public-private partnership campaign in the higher education sector and co-authored an article on the campaign implementation.
