Audit of Health and Safety Structures of the National Union of Mineworkers

Staff and students from the Department conducted an audit of the health and safety structures of the National Union of Mineworkers (NUM) commissioned by the union. They conducted fieldwork at mines in various parts of the country and produced a summary report, as well as six sector reports. A paper based in the findings will be presented at the ISA Forum (Vienna) in July 2016. The project was led by Professor Andries Bezuidenhout.

Inaugural workshop of the African Work-Family Research Network


This inaugural workshop was funded by the DST-NRF Centre of Excellence on Human Development and its aim was to bring together researchers and policy makers with an interest in work-family issues in Africa to share information on existing research and generate ideas for future collaborative work. The workshop was attended by academics, researchers and policymakers from South Africa, Nigeria, Kenya, the UK and Australia and it ended with the establishment of the African Work-Family researchers network which aims contribute and amplify the African voice in the global work-family

<p>interface discourse through various collaborative projects and events. The project is led by Professor Zitha Mokomane. Two collaborative papers have been submitted to journal for consideration.</p>
<p>Research on Racism, Sexism and Leadership Development in the Mining Sector Dr Malehoko Tshoaedi (project leader) and Professor Zitha Mokomane are conducting a research project for the Mining Health and Safety Council (administered by Business Enterprises at the University of Pretoria). The focus of the project is on racism sexism and leadership development in the mining sector, with the aim of aligning the programmes of the mining companies to the Mining Charter. The project was awarded in April 2015 and will be completed in October 2016.</p>
<p>Taking Democracy Seriously: Workers Survey 2014 This project was reported on in our 2014 report. It is led by Dr Malehoko Tshoaedi together with Prof. Andries Bezuidenhout and Ms Christine Bischoff (Wits University). The analysis of the 5th Taking Democracy Survey: was completed and the results of the survey will be published as an edited book; co-edited by Professor Andries Bezuidenhout and Dr Malehoko Tshoaedi. Publication of the book is expected in 2017.</p>
<p>Service and Research Institute on Family and Children In June 2015 Prof. Zitha Mokomane was appointed as a member of the International Advisory Board of the India-based Service and Research Institute on Family and Children (SERFAC) for a term of five years. SERFAC was inaugurated in November 1986 and obtained special consultative status with the Economic and Social Council of the United Nations in 1998. It currently functions as a global research centre on family and child policy and is one of only a few organisations worldwide to focus on the interrelatedness among human development, socio-economic issues, political and technological institutions, democratic systems and effective governance</p>
