Call for abstracts: Abstracts should be submitted by the advertised deadlines for consideration by the Scientific Committee. Abstracts may be submitted for oral/poster presentations. Acceptance and mode of presentation of abstracts will be determined by the Scientific Committee. Authors of accepted abstracts will be required to submit full papers which will be peer reviewed for publication in the conference proceedings.

Structure of the Abstract: The abstract should have the following structure:

-Title of Abstract (with the text center justified) to include the title, author(s') names and affiliations (list multiple affiliations one below the other) and mark each with a superscript "a", "b", "c",). – In addition the name of the corresponding author, where there is more than one author, should be marked with an asterisk superscript (*). A footnote should then be given on this page "*Corresponding author: E-mail: Tel.: Fax:" -The Abstract should be at most 400 words,

with 6-8 keywords

General format

-It should be one column. Leave on all sides a 2.5 cm margin and use 12 pts font, Tahoma throughout. Single spacing should be used. The text should not be hyphenated. Metric (S.I.) units should be used. Use units instead of words, e.g. "10 m" instead of "meter(s)" with a free space between number and units. Do not abbreviate units (e.g. no "pi" or "pels"

instead of "pixel(s)". Also present units as 1% and 4%, or 2 mm to 5 mm, not 2 to 5 mm, or 3 km x 3 km, not 3 x 3 km. Do not use bullets. Instead use numbering as (1) (2). There should be no footnotes.

Timelines

- Abstract submission deadline extended to 31 May 2011
- Notification of acceptance of abstract 30 June 2011
- Authors of accepted abstracts will be invited to submit manuscripts for possible publication in conference Proceedings.
- Submission date 15 July 2011

Presentation language: The abstract should be in English. The text must be well structured and understandable. English should be grammatically correct.

Submission policy: First authors are limited to two oral presentations.

Mode of presentation: Presentations are welcome in oral and poster formats.

Poster presentation format: All posters should have a uniform size of A0

Audio-visual presentation: The organizing committee will provide conference laptop and LCD projector.

Display of promotional items:

Companies are welcome to display their promotional items at a fee of R 10,000.00

Dissemination/Publications: All accepted oral presentations will be developed into manuscripts and submitted for consideration in the Conference proceedings. Papers to be included in the conference proceedings will be double blind peer reviewed.
