# Short Course in Public International Law

21 - 26 January 2013, Pretoria



### BRIEF DESCRIPTION

### WHO SHOULD ATTEND

The course is aimed at law graduates, senior-level governmental and intergovernmental officials, leaders of civil society, staff and managers of NGO's and academics.

### COURSE REQUIREMENTS

A law degree is a requirement for admission. Participants will be required to prepare reading material from the textbook by John Dugard, International Law. A South African Perspective (Juta, 4th rev. ed, 2011). In addition, primary materials will be made available on the internet in advance. Participants who have attended all lectures will receive a certificate of attendance on completion of the course.

Participants must submit a copy of their law degree with their application preferably by 13 December 2012.

### COURSE FEE (CE at UP IS EXEMPT FROM VAT)

The course fee is R 4950.00 and includes all course material and lunch. University of Pretoria students can apply for a reduced course fee of R 2500.00; proof of 2013 registration is required. Participants are responsible for their own accommodation and travel arrangements.
