## Admission requirements

- 1. A BSocSciHons (Philosophy, Politics and Economics) degree or relevant honours degree
- 2. A cumulative weighted average of at least 68% for the honours degree is required **but** students with a cumulative weighted average of 70% or more for the honours degree will receive preference
- 2. Research component passed at beneurs level
- 3. Research component passed at honours level

Note: Additional work/modules may be required in order to reach the desired level of competency in research

## Additional requirements

- Students with an average of between 68% and 70% in the majors/fields of specialisation could be considered for admission under special conditions. Apply to the programme manager.
- Prospective students may be required to do additional work/modules (for non-degree purposes) to enable them
  to reach the desired level of research capability, should it be found that they have not completed an
  appropriate research component at honours level.

## Pass with distinction

For the degree to be awarded with distinction a student must obtain a minimum of 75% for the dissertation.
