DR SEEMA PATEL

Dr Patel is a Senior Lecturer in Law at Nottingham Law School. Before joining Nottingham Law School, Seema was a Senior Lecturer in Sports Law and Management at NTU Sport Science. She has a PhD in Sports Law and is the author of "Inclusion and Exclusion in Competitive Sport; socio-legal and regulatory perspectives" by Routledge. She also teaches on the LLM Sports Law course and is also a previous graduate from the course. Her area of expertise is discrimination in sport, specifically the regulatory balance between inclusion and exclusion in sport. Dr Patel has presented her research at a number of international conferences and has also published papers in this field. She has provided expert comment to local and national press on new stories relating to discrimination in sport.
