### Admission requirements

1. Bachelor's degree in Speech-Language Pathology (NQF level 8)  
or  
Bachelor of Arts Honours in Augmentative and Alternative Communication degree  
or  
A relevant honours degree, provided that sufficient background in severe communication disability and research is evident, in which case an admissions examination may be required
2. A weighted average of at least 65% at final-year level of the previous relevant qualification
3. An average of at least 65% for the research module of the previous qualification

### Additional requirements

- An acceptable level of proficiency in English or Afrikaans is required.
- An approved research proposal is also required.

#### Module content

A dissertation based on independent research on a topic related to the field of augmentative and alternative communication, selected in collaboration with a supervisor. The dissertation should be based on an approved research proposal and ethics clearance. Use of computer programs for data analysis and report writing is required.
