Examinations and pass requirements

- i. A continuous evaluation mark of at least 50% is required for admission to the examination in the major subject.
- ii. The sequence of the examinations in the prerequisite subjects will be determined by the relevant head of department according to the major subject followed by the student.
- iii. In order to pass, a subminimum of 40% in the written and/or practical and/or clinical sections of the examination, and a final mark of at least 50%, is required in the major as well as the prerequisite subject.

Pass with distinction

The degree is conferred with distinction on a student who has obtained at least 75% in the major module, and an



average of at least 65% (not rounded) in the prerequisite modules.

University of Pretoria Programme Qualification Mix (PQM) verification project

The higher education sector has undergone an extensive alignment to the Higher Education Qualification Sub-Framework (HEQSF) across all institutions in South Africa. In order to comply with the HEQSF, all institutions are legally required to participate in a national initiative led by regulatory bodies such as the Department of Higher Education and Training (DHET), the Council on Higher Education (CHE), and the South African Qualifications Authority (SAQA).
